- as a Special Master, conducted a patent “Markman” hearing and issued a Report and Recommendation on claim construction to the District Court in *Abbott Point of Care Inc. v. Epocal, Inc.*, CV08-S-0543-NE (D. Ala.)
- arbitrated a large patent infringement case involving two Fortune 500 companies and a patent directed to a personal care product
- resolved a trademark dispute on behalf of the Martin Guitar Company, which learned a guitar manufacturer in Tennessee had begun trademarking electric guitars with the name “Mario Martin” in violation of the company’s U.S. registration of the trademark “Martin”
- obtained a favorable decision from the National Arbitration Forum Panel awarding transfer of a domain name after proving: (1) the domain name registered by the respondent was identical or confusingly similar; (2) the respondent had no rights or legitimate interests with respect to the domain name; and (3) the domain name had been registered and was being used in bad faith
- obtained a complete and voluntary dismissal, without payment of any consideration whatsoever, of the “Combination Cordless Telephone and Premise-Monitoring Alarm System” patent infringement suit filed against LifeShield Inc. by RB Technologies LLC
- on behalf of two co-defendants, obtained a stipulation of dismissal, with prejudice and without payment of any consideration whatsoever, by Surface Preparation Technologies (SPT) of a patent infringement suit filed against co-defendants Waterblasting Technologies Inc. and Guidemark Inc.; SPT asserted infringement of a patent regarding cutting rumble strips in roadways
- obtained and evaluated full trademark clearance searches, on an extremely expedited basis, for 55 product names
- retained by counsel for Greenberg Traurig as an expert witness in the case *Philip Wyers v. Greenberg Traurig* in the U.S. District Court for the District of Colorado, wherein Wyers alleged that Greenberg Traurig committed legal malpractice while representing him before the U.S. Court of Appeals for the Federal Circuit, including related settlement negotiations and a failed mediation, in a patent infringement case
- defending ITT Corporation and Exelis Inc. in an action for patent infringement brought by CANVS Corporation in the U.S. District Court in Florida; the case involves U.S. Patent No. 6,911,652, titled “Low Light Imaging Device,” and accuses certain night vision goggles manufactured by the companies and primarily used in military applications, of infringement
