Dan has tried well over 40 matters to verdict.

## RESULTS

- obtained multiple defense verdicts following jury trials in mass tort actions involving asbestos, toxic torts, pharmaceuticals and medical devices

- obtained the dismissal of a class action, following a class certification trial, against a large insurance company, where it was alleged that homeowners insurance policies required the payment of general contractor overhead and profit regardless of whether such services were required
- obtained summary judgment in favor of an insurance company client on breach of contract and bad faith claims involving a fire loss in Northeastern Pennsylvania
- obtained a verdict in favor of an insurance company client following a jury trial as to whether an exclusion for asbestos claims was void as a matter of public policy
