Brian's legal practice is centered on his representation of insurance carriers and health care systems, with specific focus on matters involving the Employee Retirement Income Security Act (ERISA), Medicaid/Medicare, managed care, fraud and provider contracting. Brian is also highly knowledgeable in judgment enforcement and execution procedures. In addition, Brian regularly partners with clients regarding their inclusion and equity strategies to ensure they are both highly effective and designed in a way that mitigates any potential risk. Brian also regularly assists clients with obtaining certification as minority- and womenowned business enterprises.

As chief inclusion officer, Brian leads firmwide inclusion and equity efforts and promotes initiatives that allow the most talented individuals to excel regardless of background or identity. Since taking on the role, Brian has charted a multi-year roadmap for Stradley Ronon to reduce bias and increase the transparency of firm processes, to offer events and trainings that honor diverse histories while unifying the firm under a shared culture of allyship, and to ensure individuals are empowered to express themselves with authenticity. Brian also works closely with the board of directors and other key members of firm leadership on belonging and recruiting issues and with the leaders of the firm's five engagement groups to create opportunities for meaningful connections among lawyers and business professionals.

Brian continues his work outside the firm, where he is heavily involved with organizations dedicated to equity and inclusion.
